Scholarships Applications

We offer scholarships to high school seniors seeking to continue their education. When the scholarship is awarded, the recipient will have the option of a one-time \$2,500 scholarship, or a 4-year scholarship of \$1,250 per year (equaling \$5,000). Scholarships are available to seniors who will graduate from La Pine, Gilchrist, and North Lake County High School, as well as high schools located in Klamath, Lake, and Deschutes Counties (including home school).

Continuing Education Scholarships

We offer \$2,500 scholarships for continuing education. These scholarships are available to members who have already graduated high school and are seeking to continue their education.

Line Worker Scholarships

We offer one \$20,000 scholarship for members to attend line worker school. Recipient must put forward \$5,000 for the remainder of the lineworker tuition. MEC will reimburse the \$5,000 once schooling is completed.

Director positions on the Board of Midstate Electric Cooperative for Districts 5, 7 and 9 are up for election at the Annual Meeting on May 20, 2023. Candidates to represent those districts may be nominated for director by filing a petition signed by at least 15 members of the cooperative who reside in that district. Below is more information regarding the districts up for election:

DISTRICT 5:

Current Director - Tanna King

District 5 (Chemult) is described as: North boundary is an East-West line one mile north of Highway 58 Junction. West boundary is the Douglas-Klamath County line. South boundary is a line four miles south of Hub City Chrome (formerly Thunderbeast Park) on Highway 97. East boundary is the Klamath County and Lake County line.

DISTRICT 7:

Current Director - Alan Parks

District 7 (Fort Rock) is described as: North boundary is the Deschutes County and Lake County line. West boundary is the Klamath County and Lake County line. East boundary extends due north from the centerline of the intersection of Oil Dry Road and the Christmas Valley Highway and due South down the centerline of the intersection of Oil Dry Road,

extending to Picture Rock Pass. South boundary is the Lake County and Klamath County Lines, with a jog North to Picture Rock Pass.

DISTRICT 9:

Current Director - Dick Luebke

District 9 (Sunriver) is described as: North boundary is the Cascade Lakes Highway. West boundary is the Lane County and Deschutes County line. East boundary is eight miles east of Highway 97. South boundary is Spring River Road (and its extension east and west.)

Winter weather typically means increased energy use at home. Keep your bills in check with these tips to save energy and money! Mind the thermostat. If you have a traditional heating and cooling system, set the thermostat to 68 degrees or lower. Consider a smart or programmable thermostat for additional savings.

Get cozy. Add layers of clothing for additional warmth, and snuggle up under your favorite heavyweight blanket.

Don't block the heat. If your air vents or heating elements (like radiators) are blocked by furniture or rugs, your home isn't being adequately heated.

Take advantage of sunlight.

Open window coverings during the day to let natural sunlight in to warm your home. Close them at night to block the chilly night air.

Block air leaks. Seal windows and exterior doors with caulk and weather stripping to improve indoor comfort and decrease the amount of energy used to heat your home.



Rate Increase Coming April 1st



As of April 1, 2023, you will see a \$3.00 increase of our Facilities Charge for all rate classes (excluding Industrial). There will also be an Energy Charge rate increase of \$0.003 per kilowatt-hour for all rate classes.

Despite our upcoming rate increase, MEC rates are well below the national average and are one of the lowest rates in the state of Oregon. MEC will continue working hard to control costs by operating safely and efficiently and to provide the most reliable electric service possible.

We realize that any increase in your power cost can cause a hardship. We are continuing to provide conservation programs that can help.

Rebates are offered for heat pumps, duct sealing, water heaters and weatherization measures. You can also monitor your energy usage through our SmartHub application.
