Operation Round Up® SMALL CHANGE. BIG DIFFERENCE.

Many Midstate Electric members "round up" their electric bill payment each month and contribute to Midstate Electric's Operation Round Up® Program.



Member's donations are put to use in several community projects in our local areas. Thank you to the 2,634 members who are currently participating!

If you are not participating in the program yet, it is simple to join in. Participants have their electric bill voluntarily "rounded up" to the nearest whole dollar amount with the extra change going into a separate Operation RoundUp® fund.

For example, if your bill is \$87.56, you will be billed an even \$88.00 and the extra \$0.44 goes toward helping various causes in the community. On average, participating members can expect to donate about \$6.00 per year, and at most, \$12.00. Together, those small amounts will make a big difference! It is an inexpensive and convenient way to give to charitable programs within the community.

Members are always welcome to donate additional funds to the program by calling the office. Program donations are tax deductible. A year-end donation total will be located on December, January, and February statements for all participants.

REMINDER - MEC Rebate Program Changes Effective October 1st:

- BPA will no longer require PTCS certification for any heat pump rebates.
 - The rebate amount for heat pump conversion from electric furnace is changing from \$1,400 to \$1,000.
 - There is a new measure: conversion from electric furnace to variable speed heat pump will have a rebate of \$1,200.
 - A heat pump upgrade measure will only be available for variable speed heat pumps with a rebate of \$200.
 - NEEM homes rebate change: NEEM 1.1 will have a \$1,200 rebate, and NEEM 2.0 will have a \$1,400 rebate.
- Rebate amounts are set by Bonneville Power Administration (BPA) and are subject to change at any time by BPA. Visit our website and click on the Energy Efficiency tab for further rebate information. Rebates are planned to remain at these levels through September 2025, but may change per BPA.
